PART A: SHORT TERM PROMOTIONS

1. HFC AND FTTN PROMOTIONAL REBATE

HFC AND FTTN PROMOTIONAL REBATE	
ELIGIBLE SPEED	REBATE (per LAL/month)
25/5 Mbps	30% off MRC
50/20 Mbps	30% off MRC
100/40 Mbps	30% off MRC
250/50 Mbps	30% off MRC
Max/50 Mbps	30% off MRC
Max/100 Mbps	30% off MRC

Table A – Promotion Particulars

Promotion Terms and Conditions

- a) This HFC and FTTN Promotional Rebate applies to the followings plans in the Price Book at the Eligible Speed:
 - FTTN Spectrum Freedom Plan;
 - HFC Layer 2 Spectrum Freedom Plan; and
 - HFC Layer 3 Spectrum Freedom Plan, (each an **Eligible Plan**).
- b) The Customer is entitled to the Rebate for each Eligible Plan that is supplied by Vision Network as at 1

October 2022 (**Existing Service**) or which is ordered by the Customer and acknowledged by Vision Network during the Promotional Period (**New Service**).

- c) For each Eligible Plan that the Customer is entitled to under paragraph (b), Vision Network will automatically apply the Rebate as follows:
- for an Existing Service, Vision Network will apply the Rebate to each monthly invoice during the Promotional Period or until the service is disconnected by the Customer, whichever occurs earliest; and
 - for a New Service, Vision Network will apply the Rebate to each monthly invoice from the date the service is connected for a 3 month period or until the service is disconnected by the Customer, whichever occurs earliest.
- d) For the purposes of these Promotion Terms and Conditions, capitalised terms have the following meaning:
- **Customer** means the customer to the Wholesale Service Agreement;
 - **Eligible Speed** means the eligible speeds set out in Table A – Promotion Particulars;
 - **Promotional Period** means 1 October 2022 to 31 December 2022; and
 - **Rebate** means the rebate set out in Table A – Promotion Particulars.
- e) Vision Network intends to consult in the lead-up to the expiry of the Promotional Period to assess whether to extend the HFC and FTTN Promotional Rebate for further periods, for example if it is successfully delivering the anticipated competition and consumer benefits of providing additional connections to Vision Network. Vision Network may extend the duration of the HFC and FTTN Promotional Rebate beyond the initial Promotional Period in its absolute discretion.
